Preschool eligibility

Children are eligible to attend four year old preschool when they are four years of age by 30 April in the year they will attend. Children born in the months of January to April can apply to start the year they are eligible or the following year.

When to apply

Applications can be submitted from the first business day in March each year, two years before children are eligible to attend four year old preschool. Applications must be submitted no later than 30 June in the year before attendance. Early applications cannot be accepted and will be returned.

Applications received after 30 June are considered late applications and will be given equal opportunity to positions during second and third round offers provided the application is received within a minimum of one week before the next round commences.

Applications for three year old preschool must be made directly with the preschool. A child who attends a three year old preschool program will not automatically be enrolled or guaranteed a place at the same preschool in the four year old program.

How to apply

Applications will require a completed application form, supporting documentation and a non-refundable application fee, payable and submitted to Council.

Families who do not live, work or study in Nillumbik with no connection are still eligible to apply, but will receive a lower priority than residents, ratepayers or families with a connection.

Supporting documentation includes proof of:

- Child's date of birth (copy of child's birth extract or passport)
- Residency (rates notice, lease agreement, contract of sale, driver's license or utility bill)
- A connection to Nillumbik (letter from a child care provider, educational provider, preschool or employer)

Application fee*:

The application fee is a non-refundable fee of \$36. A concession fee of \$18 is available to a child who identifies as Aboriginal and/or Torres Strait Islander or can supply a current copy of a health care card, concession card, humanitarian/refugee visa with their application.

Only one application fee is required from families enrolling multiple-birth children (application forms must be provided for each child).

*Fees are reviewed annually and updated on 1 July.

After you apply

Upon receipt of the application form, supporting documentation and payment, applicants will receive a letter confirming details and preferences. If this letter is not received within two weeks of submission contact Council.

An audit of preschool registrations is conducted annually in April with letters sent to all registered families, to ensure details are correct prior to offers being made in July in the year prior to attendance.
