Building a strong economy

A stronger local economy and more jobs are the aims of Council's new Economic Development Strategy, which was adopted in June.

The 10-year plan has four key objectives to:

- Improve economic development practices and programs to assist local business
- Create vibrant activity centres and employment precincts in Eltham and Diamond Creek
- Facilitate economically and environmentally sustainable use of land within the Shire's green wedge
- Enhance the visitor economy.

Council has also adopted the Equine in Nillumbik plan, which outlines opportunities to be explored to increase participation and support equine economic development projects.

More recently, Council considered the draft Major Activity Centre Structure Plans for Eltham and Diamond Creek. The drafts set out a vision and objectives for the townships and address land-use mix, shopping, services and entertainment, housing, employment, roads and transport while respecting local character. The Eltham Major Activity Centre Structure Plan was adopted in July, while the Diamond Creek plan was being considered at Council's August meeting.

Deputy Mayor Peter Clarke, Chair of the Planning Committee, said the adoption of the Eltham plan provided improvements to the 2004 plan.

"We have listened to the community. We have come to the point where we can progress to the next stage, which will be to look at any planning scheme amendments," he said.

Property rates freeze

Support for households as COVID-19 hits hard

After consideration brought on by the economic effects of the COVID-19 pandemic, Council adopted its 2020-2021 Budget in June, including a zero increase in property rates for the coming year.

Mayor Karen Egan said the adoption of the Budget was achieved in an environment unlike any other.

"The onset of the COVID-19 pandemic meant a new range of factors, which could not have been anticipated when the draft Budget was first released for public comment, had to be taken into account," Cr Egan said.

"Because of the significant financial impact on households and businesses in our Shire, Council came to the sensible, considered and compassionate decision not to increase rates in the coming year."

Chair of Finance and Governance, Councillor Bruce Ranken, said freezing the rates increase was possible because of good financial management.

"This decision reflects the solid foundations put in place by this Council through astute financial management, good decision-making and a strong track record in attracting state and federal funding," Cr Ranken said.

Key items in the 2020-2021 Budget include:

- Zero per cent rates increase (State Government-mandated cap is 2 per cent);
- \$35.8 million in capital works projects, of which \$17.2 million will be funded through external grants and contributions:
- Proposed borrowings of \$3.3 million to partly fund capital works programs and provide options to leverage any grant opportunities available during the financial year; and
- Current debt continues to be reduced with a projected net debt balance of \$6.9 million (excluding any proposed borrowings).

New bin options are wheelie good

Our expanded range of waste collection options provides more choice for residents

The new options, detailed below, include a weekly 120-litre landfill bin, a larger 140-litre fortnightly landfill bin and a free larger 240-litre weekly green waste bin. These options are in addition to those already available, so if you are happy with your current collection arrangements, you don't need to do anything and your service will continue as normal.

Council set the standard waste management charge of \$419.56 in the 2020-21 Budget, along with the charges for the additional landfill bin options.

The charge covers bin collection, processing and disposal including government levies, hard waste collection, green waste vouchers, free recycling of many items at the recycling centre, education programs and the rehabilitation of the former landfills at Plenty and Kangaroo Ground.

The new bin options come as JJ's Waste & Recycling began the kerbside collections in July. Keep an eye out for the new trucks across the Shire.

Food for thought

Victorian farmers use compost made from your food and garden waste.

Put your food scraps in the green waste bin, not the landfill bin. Nillumbik's waste audits show about one guarter of what's in the landfill bin

is food waste, even though it can go in the green waste bin.

Remember to separate food scraps from other waste during food prep and after meals, so they can be recycled into compost for farms, parks and gardens.





Your chance to vote in council elections

Nillumbik heads to the polls on Saturday 24 October in Victorian local government elections

Local Government Minister Shaun Leane has confirmed the elections are going ahead as planned with additional health and safety measures to protect the community during the COVID-19 pandemic.

The Victorian Electoral Commission (VEC) will conduct the election by post.

Ballot packs will be sent to enrolled voters in early October. The ballot packs will include voting instructions, candidate information, a ballot paper, and a reply-paid envelope.

Voting closes at 6pm on Friday 23 October.

Voting is compulsory for people over the age of 18, and those who don't risk a fine. Under the new Local Government Act 2020, voters aged 70 and over are no longer exempt from compulsory voting in council elections. Residents on the State

roll aged 70 and over will be required to vote. From 2024 all voters 70 and over will be required to vote.

Enrolments for the council elections closed on 28 August.

Nillumbik Shire Council is divided into seven wards with one councillor representing each ward.

In 2019, the VEC conducted an Electoral Representation Review where the existing seven-ward structure was retained with a slight boundary adjustment between two wards.

As legislated, Council will enter a Caretaker Period during the election period from midnight Tuesday 22 September to 6pm, Saturday 24 October. The results of the election are expected to be declared by the VEC by Friday 13 November.

Closing date for candidates

Nominations to be a candidate in the upcoming council elections open on 17 September and close at 12 noon Tuesday 22 September.

Candidates must be an Australian citizen and enrolled as a voter in Nillumbik. They must have also completed mandatory training.

Register your pool or spa

The Victorian Government has extended the deadline for the mandatory registration of private pools and spas.

Private pool and spa owners now have until 1 November 2020 to register their pools with Council an extension of five months from the original 1 June deadline.

The Government introduced new regulations in December 2019 to make swimming pools and spas safer and prevent young children from drowning.

These changes require owners to register their pools and spas with council, with a one-off fee of up to \$79. Pool barriers must then be inspected and certified.

Owners who fail to register their pool or spa with council by 1 November may face an on-the-spot fine of \$330.

Have your say on road project

An Environment Effects Statement for the Yan Yean Road upgrade Stage 2 is being prepared for public exhibition

Nillumbik residents will soon be invited to make a submission on the Environment Effects Statement (EES) for the project, which is being overseen by the Department of Environment, Land, Water and Planning.

The proposed upgrade, by Major Road Projects Victoria (MRPV), will see the duplication of Yan Yean Road between Kurrak Road and Bridge Inn Road.

The project will also include:

- Replacing roundabouts with traffic lights at Orchard Road and Bridge Inn Road
- New traffic lights at North Oatlands Road and Bannons Lane and Jorgensen Avenue
- New roundabouts at Heard Avenue and Youngs Road.

An EES looks at the potential environmental, social, cultural and economic impacts of the project and identifies how they will be managed.

After the EES exhibition, an independent panel will consider the EES and the submissions made during the exhibition period. The panel will make a recommendation to the Minister for Planning.

Nillumbik Shire Council will be making a submission on the EES.

The Business in Nillumbik section of our website has been updated to provide a roadmap of the permit application process. including an interactive checklist to help determine which permits may apply to each business' situation.

The application process has also been streamlined and, in many cases, can now be completed with a single form. Business owners are encouraged to meet with our Economic Development team who will act as concierge through the application process, providing support and advice at every step.

Big step for trail extension

Work starts on Stage 1 of the long-awaited shared path

The major project will see a 2.5km shared trail built from Diamond Creek to Wattle Glen.

The project has been funded with \$4 million from the Victorian Government, through VicRoad's Towards Zero.

Nillumbik Shire Council has committed \$4 million for land acquisition for both Stage 1 and Stage 2 of the project.

The new section will start in Luscombe Drive, Diamond Creek, and follow the Diamond Creek to Wilsons Road in Wattle Glen. It will include three bridge crossings over the Diamond and Scrubby creeks.

The trail will consist of a shared path for pedestrians and cyclists, and a separate trail for horse riders.

Nillumbik Mayor Karen Egan said the trail would provide a vital link between the townships of Diamond Creek and Wattle Glen.

"This is an important piece of community infrastructure, set in a beautiful part of our Shire," Cr Egan said.

Ellis Ward Councillor Peter Perkins thanked the State Government for its significant contribution to the trail.

"The past few months have seen our trails used more than ever before and I have no doubt that, once finished, this new trail will be enormously popular with locals and visitors alike," Cr Perkins said.

Work is expected to be completed late 2020/early 2021.

Work has almost finished on the Diamond Creek Regional Playspace and we can't wait to welcome you to this fabulous new community facility.

We look forward to officially opening the playspace when the easing of COVID-19 restrictions allow.

New dog park will be paw-some

In good news for our canine companions, Council has received \$275,000 from the Victorian Government to create a new off-leash dog park in Eltham North.

The park will be at Dansey's Paddock in Wattletree Road and include a fenced off-leash dog park area with separate zones for small or quiet dogs and big dogs.

The funding has been provided through the Victorian Government's Suburban Parks Program.

Edendale Ward Councillor John Dumaresq said residents had been asking for a dog park in Eltham North for many years.

"The community is thrilled that Council and the State Government have given the dog park the green light. It adds to the fantastic facilities in the North Eltham recreation and Edendale Farm precinct," he said.

Construction is anticipated to start in early 2021.

Solar project powers on

Council's proposed solar farm at the former Plenty landfill site is sparking interest across the community.

In late August, Council was due to consider market offers to develop the farm on the site in Yan Yean Road, next to the Recycling and Recovery Centre.

The community was invited to share their thoughts about the project through Council's Participate Nillumbik website in July.

Further community engagement will be undertaken during the solar farm development program.

The solar farm has the potential to supply all of Council's annual electricity requirements through the national electricity distribution network and will assist in significantly offsetting our greenhouse gas emissions.

Smart stuff

Nillumbik is on its way to being a smarter city following the installation of gateways and sensors that will gather data to help us improve the management of our services and facilities.

The sensors will monitor:

- Visitor numbers at Council facilities and outdoor spaces such as public toilets and shared trails
- Air quality including pollution and an early warning of bushfire smoke
- Water levels in water tank storage for bushfire fighting
- Waste volumes in public rubbish bins to alert when full bins need collection.

The Northern Melbourne Smart City Network is a collaboration between Nillumbik, Whittlesea, Banyule, Moreland and Mitchell councils, and RMIT and LaTrobe universities, and has been partly funded by the Federal Government.

Top stories

The amazing stories of some of our older residents have been brought to life as part of a unique intergenerational storytelling program.

In response to the COVID-19 pandemic, Council partnered with Humankind Enterprises to run the Digital Storytelling Program in which five young jobseekers were employed to work with 25 older community members, helping them record their stories and experiences.

The program aimed to increase social inclusion for older residents, many of whom have been forced to isolate during the pandemic. Young people have also been affected by job losses.

Book in some reading time

Our libraries are better than ever with a new rural hub and upgrade to the Diamond Valley branch

In great news for our regional townships, a library hub has been established in the foyer of the Hurstbridge Community Hub, in partnership with Yarra Plenty Regional Libraries (YPRL).

Once COVID-19 restrictions ease, the new library hub will allow library members to select their reserved books to be delivered and picked up at the Hurstbridge Community Hub. The system will be automated with a digital kiosk to facilitate the click and collect service, supported by Hub staff. Visitors will also be able to browse a small selection of books.

The YRPL mobile library will also continue to operate, subject to COVID-19 restrictions.

Residents will need to be a library member to use the library hub click and collect service, and can join for free.

Mayor Karen Egan said the new library hub was great news for rural residents.

"It's a convenient way to access a great range of resources in addition to the mobile library service," Cr Egan said.

In the meantime, planning is well underway for the upgrade to the Diamond Valley Library.

Concept designs were released for community consultation in August. These are now being finalised ready for work to start early next year.

While library branches have been closed in recent months, YPRL offers a great range of online services through the Your Library at Home program.

Working together to prepare for bushfire

Our new Community First program supports a grassroots approach to bushfire preparedness

We are pleased to have received funding from the Department of Environment, Land, Water and Planning under the Safer Together grants program to facilitate community-led bushfire preparedness activities within Nillumbik's rural communities.

The project, Community First, seeks to place the community at the centre of preparing for bushfires, build on existing capacity, collaboration and strengthening relationships with communities, agencies and Council.

The project uses a place-based, bottom-up approach to meet the unique needs of different communities by working together to use resources and share local insight to improve bushfire preparedness.

Council has employed Emergency Project Resilience Officer Edwina Moran to implement this project.

During the first phase, in recognition of local knowledge and experience, Edwina will be undertaking structured community conversations with rural residents, businesses, community groups and organisations.

We're all in this together

Bushfire prevention is a shared responsibility and Council is ensuring we play our part

Council has an annual program of works to ensure our parks and reserves, as well as the roadsides we manage, are prepared for bushfire while balancing the protection of the environment.

Our program includes fuel reduction, brush cutting and mowing in parks, reserves and open spaces, roadside mowing, box clearance (removal of vegetation around the required clear zone of the road), removal of roadside tree hazards, maintenance of roadside trees affected by the 2009 bushfires, planned burns, fire track and water tank maintenance and the clearance of vegetation from around electric lines.

The program is reviewed and developed each year in consultation with the Municipal Fire Management Planning Committee which includes the CFA, local

brigades, Council, Parks Victoria and other key stakeholders.

We are also guided by our Bushfire Mitigation Strategy 2019-2022. This strategy adopts a broad set of strategic priorities including risk-based fuel management.

Most works are scheduled to be finished by 1 December each year. We work with our contractors to schedule works as late as possible to maximise benefit and value, for example we want grass to be cured before we cut so we only need to do it once, but need to start early enough so works can be finished ahead of the peak fire season.

Protecting the Eltham Copper Butterfly

Council's bushfire mitigation works are not only essential for community safety, but for protecting endangered species such as the Eltham Copper Butterfly.

We manage a series of small reserves throughout Eltham which provide important habitat for the butterfly.

Not only could a fire be devastating or residents living near the reserves, but also the vulnerable butterfly population.

Our annual bushfire management works in the reserves include the maintenance of fire breaks, removal of fine fuels and thinning shrubby vegetation.

Prepare your property and plan now

Nillumbik is one of the highest bushfire risk areas in the world. We all have a role to play in preparing for the threat of fire. Residents are being urged to prepare their properties now, before the bushfire season begins

The CFA website has a range of ideas and information to help prepare and protect yourself and your property.

Some tips for preparing your property include:

- (V) Keep grass short
- Get rid of dry leaves, twigs and loose bark
- Keep gutters clear of leaf litter
- Keep woodpiles away from the house
- Store flammable liquids away from the house
- Prune lower branches of shrubs to separate from surface fuels underneath
- Cut back overhanging branches
- Remove flammable items such as boxes, furniture and doormats from decks and verandahs.

Being prepared also means having a written and, if possible, well-practised plan to help you and your family or employees remember what to do during an emergency.

Have you thought about:

- Which Fire Danger Rating is your trigger to leave?
- Will you leave early on a high fire danger day or the night before?
- Where will you go?
- What route will you take and what is your alternative if that is not available?
- What will you take with you?
- What do you need to organise for your pets or livestock?
- Who do you need to keep informed of your movements?
- ▲ Is there anyone outside your household you need to help or check up on?
- A How will you stay informed about warnings and updates?
- What will you do if there is a fire in your area and you can't leave?
- Who will do what?

It's in the mail

In the lead up to the Fire Danger Period, you may receive a letter advising you to prepare your property.

This letter serves as a reminder and guide for clearing your property in order to reduce potential fire hazards. Failure to adequately prepare puts you and your neighbours at risk, and may result in a Fire Prevention Notice being issued.

Fire Prevention **Notices issued**

To ensure the safety of our residents. Council officers conduct annual property inspections for properties that are covered by the Bushfire Management Overlay and other at-risk properties.

If it is identified that your property has a high level of fire risk, a Fire Prevention Notice may be issued, requesting you to conduct works on your property to reduce the risk. Council officers will be available to provide guidance. Failure to comply with this Notice may result in an infringement and/or possible court action.

Burning off

Burning off is one way to dispose of vegetation (grass, weeds, branches and leaves) as part of your fire preparedness activities.

If your property is less than once acre, a permit is required to burn off. Properties larger than once acre do not require a permit to burn off, unless the pile to be burnt is larger than 10 square metres.

Burning off is permitted from 1 October until the start of the Fire Danger Period. Burning off is prohibited on all properties, regardless of size, on any Total Fire Ban day or Smog Alert day, and at all times during the Fire Danger Period.

What am I allowed to do?

In many instances, a planning permit is required to remove or lop vegetation on Nillumbik properties, in accordance with the Nillumbik Planning Scheme.

However, there are some exemptions, guided by the 10/30 or 10/50 rules. For more information about these rules, go to our website

Before fire season

- Pack an Emergency Kit with essential items and keep it in a handy place.
- Scan important documents and photos onto a memory stick.
- Buy a battery-operated radio, powerful torch and extra batteries.
- Save important contact numbers in your mobile phone. Include family, friends and the VicEmergency Hotline. Have a spare mobile phone that you keep fully charged for emergencies. Download the VicEmergency app if you have a smartphone.
- Set aside protective clothing (long-sleeved, made from natural material such as cotton, and sturdy footwear such as leather boots) for each member of the family.
- Put woollen blankets in your car for protection in case you get caught on the road.
- Practise packing your car so you know how long it will take.
- Make arrangements with anyone you plan to visit or stay with.
- Remove any materials that could burn easily from around your home.

Mark your main routes, including back up routes and petrol stations on hard copy maps. Check cfa.vic.gov.au to see if your town or suburb has a Community Information Guide map.

Talk to neighbours or nearby friends about ways you can help each other.

Remember to prepare for your pets as well.

Make sure your pet is wearing an identification tag and add the following items to your Emergency Kit:

- suitable transport carriers or leash
- · any medications
- · dietary supplements
- food and drinking water
- a familiar item (toy, bed, treats) to help reduce stress
- spray paint phone number on your horse.

On fire risk days

- Stay updated by using more than one source of information so you will know if a fire has started near you.
- Move livestock to a safe area and put your pets in a safe place ready for loading in the car.
- Pack personal items such as a change of clothing for each person, toys for children and pets, and put them in the car.
- If your car is behind an electric garage door or gate, take it out and position it in the driveway facing out or on the side of the road.
- Remove any materials that could burn easily from around your house, on decks, verandahs and pergola areas, this includes mats and outdoor furniture.

Last things to do before you leave:

- Add final items to your Emergency Kit such as medications, prescriptions, mobile phone chargers, pet food and water for everyone.
- Pack the car, remembering your most important items such as wallet, cards, keys, banking, medical and insurance documents (these should be easily accessible on a USB stick or in an expanding file).
- Turn off the gas supply.
- Block the downpipes and partially fill the gutters with water, only if you have time.
- Make sure everyone is wearing or has access to protective clothing long pants, long-sleeved shirts and sturdy shoes such as leather boots (not sandals or runners). Clothes should be loose fitting and made from natural fibres like pure wool, heavy cotton drill or denim. Do not wear synthetics.
- Tell people you are leaving.
- Close all doors and windows and lock doors.
- Leave the front or access gate open.

Warnings and updates

Warnings are issued when a fire has started and you need to take action. It's your responsibility to understand the different types of warnings and how to access them.

You should never wait to receive an official warning before you leave. Bushfires can start, spread and become uncontrollable quickly.

There are three different levels of warnings -

Don't expect warnings to be issued in any particular order. The first warning issued could

Advice, Watch and Act and Emergency Warning.

(i)

ADVICE

An incident is occurring or has occurred in the area. Access information and monitor conditions.



WARNING (WATCH AND ACT)

An emergency is developing nearby. You need to take action now to protect yourself and others.



EMERGENCY WARNING

You are in imminent danger and need to take action now. You will be impacted.

Know your daily Fire Danger Rating

The Fire Danger Rating predicts fire behaviour (should a fire start) and how dangerous it would be to put out. The higher the rating, the more dangerous the conditions. Fire Danger Ratings feature in weather forecasts during the fire season.



WHAT DOES IT MEAN?

Levels of warnings

even be an Emergency Warning.



These are the worst conditions for a bush or grassfire. Homes are not designed or constructed to withstand fires in these conditions. The safest place to be is away from high-risk bushfire areas.

EXTREME

Expect extremely hot, dry and windy conditions.

If a fire starts and takes hold, it will be uncontrollable, unpredictable and fast moving. Spot fires will start, move quickly and come from many directions.

Homes that are situated and constructed or modified to withstand a bushfire, that are well prepared and actively defended, may provide safety.

You must be physically and mentally prepared to defend in these conditions.

EVERE

Expect hot, dry and possibly windy conditions.

If a fire starts and takes hold, it may be uncontrollable. Well-prepared homes that are actively defended can provide safety.

You must be physically and mentally prepared to defend in these conditions.

VERY HIGH

If a fire starts, it can most likely be controlled in these conditions and homes can provide safety.

HIGH
LOW-MODERATE

Be aware of how fires can start and minimise the risk. Controlled burning off may occur in these conditions if it is safe – check to see if permits or conditions apply.



The Eltham Lower Park Masterplan update has been completed and I am looking forward to works being implemented, commencing with an upgrade to the front entrance landscaping this year.



New life for historic church

Restored building a symbol of renewal for Plenty

An historic Plenty church, which was saved from demolition during the Yan Yean Road upgrade, has been restored by Major Road Projects Victoria (MRPV), and returned to the Nillumbik community.

The Plenty Church, which is almost 100 years old, was in the path of the Yan Yean Road Stage 1 upgrade.

MRPV relocated the church from River Road to the Plenty Heritage Park in 2018 and following extensive restorations, has given the building to Council for community use.

Nillumbik Mayor Karen Egan said the church would provide a new home for the Plenty Historical Society.

"This church is an important tie to the history of Plenty and Council is pleased it has been saved for future generations," Cr Egan said.

Blue Lake ward Councillor Grant Brooker described the church a symbol of renewal for the Plenty community.

"What we now have is a community asset that preserves the history of Plenty but also heralds a new chapter for the future of the area." Cr Brooker said.

Plenty Historical Society President Kerry Fitzmaurice said the building had been thoughtfully and beautifully restored.

She said the church was significant as it was representative of the Home Mission-led Methodist revival and played an important role in community life.

"It has an interesting history, built in 1925 when Plenty as a town was starting to develop," Dr Fitzmaurice said.

The building later became part of the Uniting Church before being decommissioned and used as a café and florist shop.

Rev Dr Fiona Hill, from the Diamond Valley Parish of the Uniting Church, said the church was thrilled the building had been saved for future generations.



The path towards reconciliation

Visitors to the Eltham North Adventure Playground might have seen the beautiful new mural that takes pride of place in the gathering space of the community-led Pick My Project seasonal garden honouring the Wurundjeri.

The mural by artist Tom Civil is inspired by the Wurundjeri Seasons, the Diamond Creek, billabongs and local wetlands and symbolises time since creation and the longevity of Wurundjeri culture.

Working with the Wurundjeri Woi Wurrung Cultural Heritage Aboriginal Corporation, Council is assisting in the project's delivery in partnership with the Nillumbik Reconciliation Group and the Pick My Project Community Reference Group.

Planting of the seasonal garden by the NARRAP team and Indigenous Design will take place soon, with further works continuing.





Council introduces expanded range of kerbside waste collection options

While we would continue to encourage residents to reduce household waste wherever possible, larger households and those with additional needs (such as families with children in nappies) may appreciate the options for a larger fortnightly landfill bin or a weekly landfill bin collection.
